ADJOURNMENT

Speaker: Honourable Members, before we adjourn, I have further communication to make regarding changes in Minority Coalition leadership. This morning, I received a communication from the Minority Coalition of Parties of this County Assembly. The communication is in regards to the changes in leadership of the Minority Coalition of this House. The communication was informed of minutes by the Majority Coalition meeting.

Honourable Members, Changes are in line with Standing Order No.22 of County Assembly Standing Orders, County Assembly Standing Orders, which is in regards to the Leader of Minority Party and the Deputy Leader of Minority Party, that the second-largest Party or coalition of parties in the County Assembly shall (a), elect a member of the County Assembly belonging to the Party or coalition of parties to be the Leader of Minority. (b), A Member of the County Assembly belonging to the Party or coalition of parties to be the Deputy Leader of Minority. (2) In electing members under Paragraph (1), the second-largest Party or coalition of parties in the County Assembly shall take into account (a). Any existing coalition agreement entered into pursuant to Political Parties Act. (b) It should also consider the need for gender balance, and (c) the interests of special groups.

A member elected under Paragraph (1) may be removed by majority of votes of all Members of the second-largest Party or coalition of parties in the County Assembly. The removal of a Member from office under Paragraph (3), which I have just read, shall not take effect until a member is elected in a manner provided for under Paragraph (1), in his or her place. (5). The Whip of the second-largest Party or coalition of parties in the County Assembly shall follow it upon decision being made under this Standing Order communicate to the Speaker, in writing, the decision together with the minutes of the meeting at which the decision was made. A Leader of Minority Party, his or her Deputy, or coalition of parties, shall transact business for a minority government.

Honourable Members, in accordance with the procedural guidelines, the first meeting to address the removal of Honourable Samuel Lomodo Lokaale as the Leader of Minority was convened on 15th October, 2024. During this session, the specific allegations against him were presented, discussed and deliberated upon by Members of the Minority coalition, where the Honourable Member was present as per the minutes shared with me.

Following this initial meeting, a subsequent session was held on 16th October, 2024, during which new officials were elected to represent the Minority coalition interests. The following Members have been therefore been appointed; Honourable Vincent Ekipor for

Leader of Minority, Honourable Lydia Ejore for Deputy Leader of Minority and Honourable Julius Apuron for Minority Whip. The rest of the leadership positions remain as they were. In this meeting, Honourable Samuel Lomodo Lokaale was present but did not participate in the elections of the new leadership of the minority coalition. These changes take effect immediately, and result in automatic adjustments to the respective Committee Membership to reflect the new leadership structure. The House stands properly guided.

Having made that communication, the House stands adjourned until tomorrow, 9.30 a.m.
